#### **COMMITTEE REPORTS:**

<u>Curriculum Committee</u> – Trustee Bower shared that they went over the different areas of the curriculum including the strengths and weaknesses and compared them between the different buildings.

Trustee Oudette added that at the meeting they shared how they collect the data of the curriculum and also discussed on what they can do to improve going forward.

<u>District Planning Team</u> – Superintendent Krueger shared the planning team reflected on the goals established and what has the greatest need. Currently they are looking into student attendance.

<u>District Safety and Facilities Committee</u> – Trustee Casinelli reported that the committee meeting was broken down into two elements for discussion. The first topic was equipment which included an ADP and CPR program. The second topic was drills and training.

President Tomasine shared that some of the equipment discussed was a visitor's manager program. The program would be a scanning system to scan individual's identification who enter the buildings.

Superintendent Krueger shared that at the next meeting they will learn more about the visitor's manager program.

<u>Elementary Building Planning Team</u> – Trustee Bower shared that the planning team showed a slideshow with different costumes of the Newfane Elementary Students for their Halloween celebration.

<u>Health & Wellness Committee</u> – Trustee Benoit shared that there was discussion on counseling programs including mobile counseling.

<u>High School building Planning Team</u> – Trustee Oudette reported that they talked about the agenda and that there are some cool things in the work for the High School. There was also a discussion about the courtyard clean up and possibly looking into having landscapers come to help.

<u>Technology Committee</u> – Trustee Dunn reported on the Newfane website update and that two programs (Apptegy and ParentSquare) are being looked into for possibly the 2024-2025 school year.
